

Privacy Policy for YouTube

1. General Information and Scope

This Privacy Policy applies to the profile of HWI pharma services GmbH on www.youtube.com (hereinafter 'YouTube profile').

4. Details of Processing

You can interact with the Operator of the YouTube profile (e.g. share, like, dislike, comment) whilst you are logged in with your personal YouTube profile. In this case, your data will be collected by YouTube and made available to the Operator (e.g. your user name and your profile picture). In certain circumstances, the Operator may undertake storage and further processing. The Operator neither stores this data on its own systems nor further processes this data systemically for occasional information purposes.

The Operator uses this data for the purposes of providing videos to illustrate the services and products offered. This processing is undertaken pursuant to Art. 6 (1) (f) of the GDPR (legitimate interest). The legitimate interest fulfils the objective of optimisation of the YouTube profile of the Operator and the contents published therein.

5. Recipients

The data collected upon retrieval and use of the YouTube profile is transferred to YouTube's server in the USA and stored there. The transfer of data to a third country, such as the USA, is admissible under the provisions of Art. 46 of the GDPR and on the basis of the effective standard clauses on data protection included in the contractual relationship with Google.

Your data may, furthermore, be disclosed to persons within HWI pharma services GmbH who are involved in processing and administering the YouTube profile.

6. Storage Period

7. Data Subject Rights

You have the right within the framework of retrieval and use of the YouTube profile to assert any of the rights described in this chapter against the Controller.

You have the following rights: you have a right of access (Art. 15 GDPR), rectification (Art. 16 GDPR), erasure (Art. 17 GDPR), restriction of processing (Art. 18 GDPR) and data portability (Art. 20 GDPR).

Insofar as your personal data is processed on the basis of Art. 6 (1) (f) of the GDPR, you have a right to object on grounds relating to your particular situation or to the extent that the objection is related to direct marketing (Art. 21 GDPR). In the case of an objection to direct marketing, you will no longer receive any marketing messages from the Controller.

Consent granted to the processing of personal data may be withdrawn at any time with future effect. The lawfulness of processing until the withdrawal remains unaffected. You have the right to lodge a complaint at any time with a supervisory authority (Art. 77 GDPR).
